Concerning the Approval of the Instruction №. 01/2005

on Holidays Applicable to Financial Institutions

THE GOVERNING BOARD

Pursuant to:

- 1. Section 17.b of Regulation N^o. 2001/30 giving BPA the authority to issue rules, instructions, and guidelines;
- 2. Section 46 of Regulation No. 2000/8 on the regulatory and supervisory powers of the BPA;
- 3. Law No. 10/2005 dated 10 August 2005 on National Holidays and Official Commemorative Dates;
- 4. Section 165 of the Constitution of the Democratic Republic of Timor-Leste concerning the continued applicability of Laws in force at the date adoption of the Constitution.

Taking into Account:

- 1. The need regulate the minimum working hours and working days on which financial institutions shall offer services to the public;
- 2. The need for the public to know with certainty the dates on which financial settlements and other transactions undertaken by financial institutions in Timor-Leste shall take place.

HEREBY RESOLVES TO ADOPT THE FOLLOWING

Instruction №. 01/2005 on Holidays Applicable to Financial Institutions

Article 1 Applicability

This instruction applies to all financial institutions licensed to operate in Timor-Leste.

Article 2 Business Hours

Financial institutions shall be open for business from Monday to Friday on official working days in Timor-Leste;

2. The minimum hours during which financial institutions shall be open on business days shall be from 9:00 a.m. to 15:30 p.m.

Article 3 National Holidays

1. Financial institutions may be closed for public business on national holidays as defined in the Law on National Holidays and Official Commemorative Dates;

National holidays for the purpose of this Instruction shall be as follows:

a). National Holidays with Fixed dates:

May 1
May 20

November 2
November 12

- b). National Holidays with Variable Dates:
 - Good Friday;

Idulfitri "Final Day of Ramadhan";

- Idul Adha "Sacrifice Day".
- 3. BPA may from time to time declare further holidays applicable to financial institutions by written memo signed by the General Manager.

Article 4 Effect of previous Instructions

Instruction No. 01/2004 dated 22 January 2004 shall be superseded by this Instruction.

Article 5 Entry in effect

This Instruction shall enter into effect upon its signature.
